Camp will run for 2 hours. Camp start time can change, pending weather. But you will be notified prior to camp of this time change.

The fee for the day is currently \$42.00 and includes applicable taxes and treats. Canine chauffeur service within Goderich is currently \$8.00. All prices are subject to change at any time regardless of booking.

Forest Tails reserves the right to delete any bookings made, with prior written notice to the customer. Forest Tails reserves the right of refusal to the customer.

The client further agrees to pay for their pet's day at camp at time of booking.

I understand that there are benefits and risks associated with dogs socializing in a cage free setting and I agree that the benefits outweigh the risks. I accept those risks.

I understand that Forest Tails is relying on my representation of my canine camper's behaviour and medical condition and that my canine camper is in good health.

I understand and agree that I am fully responsible for any harm my pet causes to another pet while attending Forest Tails.

I fully understand that dogs naturally play and that my dog may sustain injuries. At Forest Tails all canine campers are monitored by our staff, however accidents and injuries, etc. may occur despite supervision.

I have provided Forest Tails with full disclosure regarding my canine camper's behaviour. My canine camper has not shown aggression towards any pet or person. I agree that if my canine camper shows any such behaviour that I will advise Forest Tails immediately.

My canine camper has had a routine physical examination in the past year and is up to date on the required vaccines for admittance to Forest Tails.

My canine camper has had a negative fecal in the past year.

During the period of May to November, sometimes longer I agree that I will put my canine camper on flea & tick prevention. I understand that Forest Tails will not be responsible if my camper gets fleas or ticks.

I agree that my canine camper will be spayed/neutered, or my canine will not be able to attend daycare until such time that this has occurred.

I agree that by allowing my canine to attend Forest Tails that neither Forest Tails nor any of its directors, volunteers or employees will be liable financially or otherwise for injury, illness, death or escape of my pet providing that reasonable care and precautions were taken. I release Forest Tails and its directors, volunteers and employees from any and all loss, costs, damages or liability that may occur to my canine while my canine is in the care of Forest Tails.

I agree that if at any point in time my canine camper is not behaving appropriately with the other canine campers that it is understood my canine will have some "quiet time" away from the other campers and will be reintroduced once my canine is calmer and well behaved. I agree that, if necessary, my canine camper may be leashed to one of the trained staff for closer supervision or sectioned off from the other campers if necessary.

I understand that Forest Tails, in its sole discretion, may decide whether or not to readmit my canine camper if my canine camper is displaying unwanted behaviour.

I agree that any behaviour or health issues that arise while my canine is at day camp at Forest Tails will be treated as deemed by Forest Tails to be in the best interests of my canine. First the client will be contacted to decide. If client is unreachable, the individual listed as the emergency contact will be contacted to decide. If neither can be reached, FT owner/staff will take whatever measures they deem reasonable including, but not limited to, veterinary visits, the purchases and administration of medication, or surgery. The client hereby agrees to be responsible for the costs of the aforementioned measures.

Media & Content Consent: At Forest Tails, we occasionally capture photos and videos during camp to share the joy of our adventures. These may be used on our website, social media, or in partnership with pet-related brands.

I agree to allow the individual named below as my alternate handler to pick up my canine camper if I am unable to do so. I will advise Forest Tails by telephone or text who will be picking up my canine camper and acknowledge that any person other than me may be asked for identification to ensure the safety of my canine camper.

We will need verification of the following vaccinations & health information: Please email us a copy

1. DHPP (Distemper, Hepatitis, Parvovirus & Parainfluenza) required. A 3 yr. vaccine booster is common.
2. Bordetella – required every 12 months for kennel cough, ideally less than 6 months prior to arrival. This is usually only given at pet owners request.
3. Rabies: 1 or 3 yr. vaccine required.
4. Leptospirosis: Highly Recommended-Given in a series of 2 shots, good for 12 months
5. Fleas & Ticks: All dogs should be flea and tick free prior to arrival and treatment should be current.
6. Canine Influenza- recommended but not mandatory

If an updated vaccine is needed, this should be administered at least 3 days prior to arrival at camp.

Enforcement of the Rules: Forest Tails reserves the right to refuse admittance to any canine camper who:

- Lacks proof of vaccination
- Displays evidence of untreated or potentially contagious conditions
- Fails Forest Tails standard health and temperament requirements
- Demonstrates aggressive behaviour
